LAFCU does not charge you to issue an additional Visa card for a family member (or anyone else you'd like to add to your account.) To request a card, fill out the application below. By signing this form you agree to assume full responsibility for any and all charges made by the Authorized User.

LIABILITY: Authorized Users must be at least 16 years old. The Member/Visa® credit card holder is responsible for payment of all transactions made by the Authorized User. In accordance with Federal Law and the USA PATRIOT Act, all financial institutions are required to obtain, verify, record and retain information that identifies every person doing business at or through their institution. In processing your request, we require your legal name, Taxpayer Identification Number (TIN), residential and mailing addresses, date of birth, and any other information that will allow us to identify you. **We also require clear and legible photocopies of at least one (1) form of unexpired government issued photo identification from you and the Authorized User(s) on your credit card loan account(s) reflecting the individual's current residential address.** The identification and information that you and any Authorized Users provide will be verified, which may include credit and debit bureau inquiries. We do business in accordance with the Equal Credit Opportunity Act.
