

**Relationship Rewards Available Now** 

AFCU is pleased to announce our "Relationship Rewards" program became \_available on March 1. Every member is automatically enrolled in our program that recognizes you for deepening your financial relationship with us. Your former Value, Imperial or Premier level has been converted to a new level based on your relationship with us.

At the end of each month, your relationship rewards will be recalculated, and your account will be updated, based on the number of points earned. The maximum is 5 points, with 1 point earned for each of these categories\*:

### Earn up to Five Relationship Rewards Points

- Active Checking (when you make 5+ debit card transactions from your checking account in a month)
- Savings & Investments (when you have \$10,000+ in deposits)
- Vehicle Loan or Visa® Credit Card (in good standing)
- Home Loan (a mortgage, home equity, or energy loan in good standing)
- Loyalty (a LAFCU member 15+ consecutive years)

### You will be Placed in One of Three Relationship Levels

The new levels are Bronze, Silver, & Gold...and just like sports awards, you are a winner at each level. Members at any level can apply for a Free Checking account and enjoy free access to 30,000+ local and nationwide ATMs. Relationship Rewards allows you to maximize benefits based on your entire household, which includes all LAFCU members residing at your address. Your entire household benefits from the same relationship level. If you would like to remove yourself from a household and create your own standalone household, let us know. Your level is displayed on the bottom of the last page of your paper or online accounts statements and will be viewable inside online banking as of July 2021.

credit, and Signature loans. Excluded from discounts are Shared/Certificate Secured, Visa credit cards, Student loans, Investor Mortgages, & Home Loans.


